The hot drinks industry within the NAFTA countries had a total market value of \$31,177.1 million in 2023. The Canada was the fastest growing country, with a CAGR of 11.9% over the 2019-23 period.
- Within the hot drinks industry, the US is the leading country among the NAFTA bloc, with market revenues of \$24,184.1 million in 2023. This was followed by Canada and Mexico, with a value of \$3,750.9 and \$3,242.1 million, respectively.
- The US is expected to lead the hot drinks industry in the NAFTA bloc, with a value of \$27,990.9 million in 2028, followed by Canada and Mexico with expected values of \$4,674.2 and \$4,015.0 million, respectively.
