- The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The hotels & motels industry within the NAFTA countries had a total market value of \$3,29,567.9 million in 2023. The Mexico was the fastest growing country, with a CAGR of 14.8% over the 2019-23 period.
- Within the hotels & motels industry, the US is the leading country among the NAFTA bloc, with market revenues of \$2,52,293.4 million in 2023. This was followed by Mexico and Canada, with a value of \$46,002.1 and \$31,272.5 million, respectively.
- The US is expected to lead the hotels & motels industry in the NAFTA bloc, with a value of \$3,36,948.5 million in 2028, followed by Mexico and Canada with expected values of \$61,802.4 and \$41,014.3 million, respectively.
