- The pasta & noodles market consists of the retail sale of dried pasta, dried & instant noodles, chilled pasta, chilled noodles, ambient pasta and ambient noodles. The market is valued according to retail selling price (RSP) and includes any applicable taxes. Any currency conversions used in the compilation of this report have been calculated using 2023 annual average exchange rates.
- The global Pasta & Noodles market had total revenues of \$85,134.0 million in 2023, representing a compound annual growth rate (CAGR) of 8.4% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 4.8% between 2018 and 2023, to reach a total of 27,470.5 million kilograms in 2023.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 6.8% for the five-year period 2023-2028, which is expected to drive the market to a value of \$118,021.5 million by the end of 2028.
