- Within the travel & tourism industry, China is the leading country among the BRIC nations with market revenues of \$4,66,267.5 million in 2023. This was followed by India, Brazil and Russia with a value of \$2,22,430.7, \$1,36,482.4, and \$79,744.7 million, respectively.
- China is expected to lead the travel & tourism industry in the BRIC nations with a value of \$9,31,891.0 million in 2028, followed by India, Brazil, Russia with expected values of \$3,41,610.6, \$2,09,553.4 and \$1,56,837.7 million, respectively.
