Following a difficult 2023, which was impacted by warm temperatures and a virtually absent winter, in 2024 baked goods recorded positive retail value growth of 3%, and retail volume growth of 2%. This improvement is largely attributed to cooler temperatures and an earlier arrival of winter, which is usually associated with a higher consumption of baked goods. As such, consumers were reaching for items such as breads, cakes, dessert pies and tarts earlier in the year, aiding sales. Consequently,...
