Overall, volume sales for edible oils in Serbia in 2024 are expected to fall. The government removed price restrictions on sunflower oil in 2024, which were RSD219.99/litre prior to the removal. On top of this, the government also imposed restrictions on imports on agricultural and food products for a period of nine months from March 2024. This was to protect domestic producers. Both these measures led to price rises for sunflower oil, Serbia's most popular edible oil, and is expected to result...
