- The Canadian Cat care market recorded revenues of \$2,285.7 million in 2023, representing a compound annual growth rate (CAGR) of 3% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 1.2% between 2018 and 2023, to reach a total of 213.4 million kilograms in 2023.
- The performance of the market is forecast to follow a similar pattern with an anticipated CAGR of 3.8% over 2023-28, which is expected to drive the market to a value of \$2,756.1 million by the end of 2028.
