- The Swiss Cat care market recorded revenues of \$850.6 million in 2023, representing a compound annual growth rate (CAGR) of 2.2% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 0.5% between 2018 and 2023, to reach a total of 75.7 million kilograms in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 5.5% over 2023-28, which is expected to drive the market to a value of \$1,112.3 million by the end of 2028.
