Summary

Forest Products in Europe industry profile provides top-line qualitative and quantitative summary information including: market size (value 2018-23, and forecast to 2028). - The European forest products market recorded revenues of \$106.5 billion in 2023, representing a compound annual growth rate (CAGR) of 1.1% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 0.1% between 2018 and 2023, reaching a total of 903 million m3 in 2023.
- Germany accounted for the largest share of the European forest products market at 18.7% in 2023.
