- The Indian hot drinks market had total revenues of \$8,709.8 million in 2023, representing a compound annual growth rate (CAGR) of 6.6% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 4% between 2018 and 2023, to reach a total of 1,138.5 million kilograms in 2023.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 6% for the five-year period 2023-28, which is expected to drive the market to a value of \$11,642.6 million by the end of 2028.
