- The Chinese meat & livestock market had total revenues of \$193,004.1 million in 2023, representing a compound annual growth rate (CAGR) of 2.4% between 2018 and 2023.
- Market production volume increased with a CAGR of 2.2% between 2018 and 2023, to reach a total of 89.8 million tonnes in 2023.
- China accounted for 58.2% of the Asia-Pacific meat and livestock market in 2023.
