- The expansion in the market is propelled by technologically advanced and specialized products, particularly protective coatings. The heightened demand for these coatings is primarily attributed to the increased needs of automobile manufacturing as well as the oil and gas exploration sector. For instance, according to GlobalData, the France automotive manufacturing market stood at an estimated \$32.2 billion in 2023, an increase of 8% from the previous year.
