- Market consumption volume increased with a CAGR of 2.5% between 2018 and 2023, to reach a total of 85.3 million units in 2023.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 3% over 2023-28, which is expected to drive the market to a value of \$519.3 million by the end of 2028.
