- The German Pet healthcare market recorded revenues of \$612 million in 2023, representing a compound annual growth rate (CAGR) of 2.5% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 0.2% between 2018 and 2023, to reach a total of 93.1 million units in 2023.
- The performance of the market is forecast to follow a similar pattern with an anticipated CAGR of 2.3% over 2023-28, which is expected to drive the market to a value of \$686.5 million by the end of 2028.
