- The South African Pet healthcare market recorded revenues of \$18.8 million in 2023, representing a compound annual growth rate (CAGR) of 1.3% between 2018 and 2023.
- Market consumption volumes declined with a negative CAGR of 0.4% between 2018 and 2023, to reach a total of 4.7 million units in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 2.2% over 2023-28, which is expected to drive the market to a value of \$21.0 million by the end of 2028.
