- Market consumption volume increased with a CAGR of 1.2% between 2018 and 2023, to reach a total of 20.1 million units in 2023.
- The performance of the market is forecast to follow a similar pattern with an anticipated CAGR of 2.9% over 2023-28, which is expected to drive the market to a value of \$147.2 million by the end of 2028.
