- The Swiss Pet healthcare market recorded revenues of \$69.8 million in 2023, representing a compound annual growth rate (CAGR) of 2.6% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 0.5% between 2018 and 2023, to reach a total of 7.5 million units in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 5.1% over 2023-28, which is expected to drive the market to a value of \$89.7 million by the end of 2028.
