It does not include cash inflows or net flows. Life and pension assets, unquoted equity, and real estate are excluded from the market scope.
- The Canadian retail savings & investments market recorded investments of \$3,498.0 billion in 2023, representing a compound annual growth rate (CAGR) of 6.5% between 2018 and 2023.
- The deposits segment accounted for the market's largest proportion in 2023, with total investments of \$1,554.4 billion, equivalent to 44.4% of the market's overall value.
- According to GlobalData, in 2023, the Canadian retail savings & investments market recorded an annual growth of 2.0%. The growth is attributed to the increase in the Standard and Poor's/Toronto Stock Exchange Composite Index (S&P/TSX) which bolstered investor confidence, leading to heightened participation in equity markets among retail investors.
