It does not include cash inflows or net flows. Life and pension assets, unquoted equity, and real estate are excluded from the market scope.
- The French retail savings & investments market recorded investments of \$2,944.4 billion in 2023, representing a compound annual growth rate (CAGR) of 4.0% between 2018 and 2023.
- The deposits segment accounted for the market's largest proportion in 2023, with total investments of \$2,112.8 billion, equivalent to 71.8% of the market's overall value.
- The expansion of the French retail savings & investments market is driven by the rise in disposable income encouraging individuals to allocate surplus funds toward savings products such as deposits and expand their investment portfolios with equities, mutual funds, and bonds. According to Eurostat, in 2023, the net disposable income per household in France reached \$57,372.2, up 6.9% over 2022.
