It does not include cash inflows or net flows. Life and pension assets, unquoted equity, and real estate are excluded from the market scope.
- The UK retail savings & investments market recorded investments of \$3,972.2 billion in 2023, representing a compound annual growth rate (CAGR) of 3.1% between 2018 and 2023.
- The deposits segment accounted for the market's largest proportion in 2023, with total investments of \$2,307.7 billion, equivalent to 58.1% of the market's overall value.
- The expansion of the UK retail savings & investments market is attributed to the rise in disposable income encouraging individuals to allocate surplus funds toward savings products and expand their investment portfolios. According to Eurostat, in 2023, the net disposable income per household in the UK reached \$63,925.6, up 3.4% over 2022.
