Summary

- The Canadian Spirits market had total revenues of \$16,132.0 million in 2023, representing a compound annual growth rate (CAGR) of 5.1% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 5.6% between 2018 and 2023, to reach a total of 459.1 million liters in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 10.6% for the five-year period 2023-28, which is expected to drive the market to a value of \$26,753.3 million by the end of 2028.
