- The European Spirits market had total revenues of \$184,645.4 million in 2023, representing a compound annual growth rate (CAGR) of 4.8% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 2.7% between 2018 and 2023, to reach a total of 5,530.8 million liters in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 12% for the five-year period 2023-28, which is expected to drive the market to a value of \$324,876.4 million by the end of 2028.
