Summary

All currency conversions used in the creation of this report have been calculated using constant annual average 2023 exchange rates.
- The North American Spirits market had total revenues of \$158,750.1 million in 2023, representing a compound annual growth rate (CAGR) of 6.2% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 10.6% between 2018 and 2023, to reach a total of 7,843.8 million liters in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 9.7% for the five-year period 2023-28, which is expected to drive the market to a value of \$252,583.6 million by the end of 2028.
