Summary

Crude steel production refers to the production of the first solid steel products upon solidification of liquid steel. It includes ingots (in conventional mills) and semis (in modern mills with continuous casting facilities). Crude steel also includes liquid steel, which goes into the production of steel castings.
- The Australian steel market recorded revenues of \$4,573.8 million in 2023, representing a compound annual growth rate (CAGR) of 4.8% between 2018 and 2023.
- Market production volumes declined with a negative CAGR of 0.8% between 2018 and 2023, reaching a total of 5,459.2 thousand tonnes in 2023.
- In terms of market value, fluctuating global steel prices have significantly affected the Australian steel market. The volatility caused by geopolitical tensions, such as trade disputes with major partners, has created uncertainty in pricing.
