It includes ingots (in conventional mills) and semis (in modern mills with continuous casting facilities). Crude steel also includes liquid steel, which goes into the production of steel castings.
- The South African steel market recorded revenues of \$3,614.3 million in 2023, representing a negative compound annual growth rate (CAGR) of 5.5% between 2018 and 2023.
- Market production volumes declined with a negative CAGR of 5.1% between 2018 and 2023, reaching a total of 4,871.0 thousand tonnes in 2023.
- The rising GDP has significantly contributed to the growth of the steel market, as expanding economies increase demand for steel in infrastructure, construction, and industrial projects. According to the South African Reserve Bank, the real GDP annual growth of South Africa stood at 0.6% in 2023.
