- Steel market consists of the production of crude steel in the stated country or region. Crude steel production refers to the production of the first solid steel products upon solidification of liquid steel. It includes ingots (in conventional mills) and semis (in modern mills with continuous casting facilities). Crude steel also includes liquid steel, which goes into the production of steel castings.
- The Spanish steel market recorded revenues of \$9,193.7 million in 2023, representing a compound annual growth rate (CAGR) of 0.5% between 2018 and 2023.
- Market production volumes declined with a negative CAGR of 4.4% between 2018 and 2023, reaching a total of 11,435.4 thousand tonnes in 2023.
- The market value of the Spanish steel market has contracted, largely driven by a reduction in domestic demand in key sectors such as automotive and construction. Spain's sluggish economic recovery post-pandemic has limited growth in steel consumption.
