- Steel market consists of the production of crude steel in the stated country or region. Crude steel production refers to the production of the first solid steel products upon solidification of liquid steel. It includes ingots (in conventional mills) and semis (in modern mills with continuous casting facilities). Crude steel also includes liquid steel, which goes into the production of steel castings.
- The Dutch steel market recorded revenues of \$3,868.9 million in 2023, representing a negative compound annual growth rate (CAGR) of 2.2% between 2018 and 2023.
- Market production volumes declined with a negative CAGR of 7.3% between 2018 and 2023, reaching a total of 4,676.3 thousand tonnes in 2023.
- The contraction in the market value of the Dutch steel market was primarily driven by weakening domestic demand in key sectors like construction and automotive manufacturing.
