- Steel market consists of the production of crude steel in the stated country or region. Crude steel production refers to the production of the first solid steel products upon solidification of liquid steel. It includes ingots (in conventional mills) and semis (in modern mills with continuous casting facilities). Crude steel also includes liquid steel, which goes into the production of steel castings.
- The US steel market recorded revenues of \$100,463.7 million in 2023, representing a compound annual growth rate (CAGR) of 4.6% between 2018 and 2023.
- Market production volumes declined with a negative CAGR of 1.2% between 2018 and 2023, reaching a total of 81,392.2 thousand tonnes in 2023.
- The increase in real Gross Value Added (GVA) in industry annual growth has been a key driver for the steel market. In 2023, the US real GVA in the industrial sector grew by 1.2%, according to the United Nations Statistics Division (UNSTAT). This rise in industrial activity led to higher steel consumption for machinery, equipment, and construction materials.
