It includes ingots (in conventional mills) and semis (in modern mills with continuous casting facilities). Crude steel also includes liquid steel, which goes into the production of steel castings.
- The Turkish steel market recorded revenues of \$31,985.2 million in 2023, representing a compound annual growth rate (CAGR) of 6.3% between 2018 and 2023.
- Market production volumes declined with a negative CAGR of 2.0% between 2018 and 2023, reaching a total of 33,713.7 thousand tonnes in 2023.
- Turkey has long been one of the leading steel producers in the region; however, economic instability and inflationary pressures have significantly impacted the market. According to GlobalData, the energy price inflation in Turkey stood at 67.2% in 2023.
