Other hot drinks in Bulgaria continued to be shaped by chocolate-based flavoured powder drinks, with all other types registering negligible on- and off-trade sales at the end of the review period. However, the demand for chocolate-based flavoured powder drinks remained low, compared to coffee, and even tea. Off-trade volume growth also remained marginal in 2024. While consumption was stable, slower, but still significant inflation led consumers to cut down or avoid spending on non-essential purc...
