Total processed fruit and vegetables packaging volumes saw a second year of decline in the Netherlands in 2023, although this was a normalisation process after seeing exceptional growth during the COVID-19 pandemic, and volumes remained above the 2019 level. However, while shelf stable fruit and vegetables saw rising packaging volumes, the larger frozen processed fruit and vegetables category saw a decline. Within frozen processed vegetables, one of the main pack types, folding cartons, took a h...
