In total unit volume terms, the Dutch soft drinks packaging market recorded positive growth in 2023, after stagnating a year earlier. While the main pack type, PET bottles, recorded positive growth in 2023, it continued to lose share to metal beverage cans in this year. Cans are easy to stack and store, chill faster, and are conducive to 360-degree graphics and branding. PET bottles and metal beverage cans dominate packaging unit volumes in carbonates, the biggest soft drinks category, thanks to...
