After yoghurt, cow's milk remained the most significant category in terms of dairy packaging volumes, and continued to see growth in 2023. Shelf stable milk accounted for much higher unit volumes, and also continued to record growth. Within cow's milk, although brick liquid cartons remained the leading pack type in Turkey in 2023, gable top liquid cartons saw a slightly higher increase. Thi...
