Soft drinks packaging in Ukraine recorded growth in 2023, after having registered a major decline in 2022, when the war in Ukraine started. The positive growth in 2023 was due to the stabilising of economic conditions and supply chains. The main issue facing the Ukrainian packaging industry in 2022 was the disruption in the supply of raw materials due to the war, but, as conditions were stabilising, this disruption was lessening. Although PET bottles recorded a slight decline in unit volumes in...
