In off-trade terms, soft drinks registered its highest volume growth rate of the review period. The rate of inflation in Slovakia and unit price increases slowed down significantly in soft drinks at the end of the review period; however, increasing commodity prices of sugar and rising production costs maintained strong average unit price growth.
