The surge in urban housing demand, particularly in areas with elevated noise pollution, has further driven the adoption of acoustic insulation in residential settings. By minimizing noise from external sources, acoustic insulation improves living standards, making it a preferred choice for modern housing.

Among materials, stone wool has emerged as a leader in the acoustic insulation market, achieving a valuation of USD 5.1 billion in 2023. Known for its durability and exceptional sound absorption capabilities, stone wool is a preferred material for addressing noise-related challenges in diverse applications. Its fibrous structure effectively dampens sound waves, making it suitable for reducing noise transmission and reverberation in various settings. This versatility, coupled with its ability to tackle both air-borne and structural noise, has fueled its growing adoption.

The building and construction sector accounted for approximately 39% of the market share in 2023. Acoustic insulation is pivotal
