The combination of these factors-water treatment, rising meat consumption, and health-driven seafood demand-is propelling the growth of the phosphate salts market.

The market is segmented based on grade, with food, technical, and pharmaceutical grades. In 2024, the technical-grade segment is projected to account for USD 53.1 billion. This grade is essential for metal surface treatment, where it helps form protective coatings on metals, enhancing their hardness, appearance, and conductivity. The demand for technical-grade phosphate salts is expected to grow as industries such as automotive and construction expand globally.

Regarding product types, the market is divided into various phosphate salts, with ammonium phosphates expected to hold a dominant market share in 2024. These salts are crucial for enhancing crop growth, which is vital for meeting the demands of the growing global population. They are also used in industries like paint and coatings for their flame-retardant and curing properties,
