The services include the outsourcing of functions such as customer relationship management, finance & accounting, human resources, knowledge process outsourcing, procurement, and vertical-specific processes. The total value of the market represents the demand for the service coming from a particular country.
- The Australian BPO services market recorded revenues of \$9.3 billion in 2023, representing a compound annual growth rate (CAGR) of 6.2% between 2018 and 2023.
- The hr outsourcing segment accounted for the market's largest proportion in 2023, with total revenues of \$3.4 billion, equivalent to 36.2% of the market's overall value.
- In 2023, Australia accounted for a share of 9.0% of the Asia-Pacific BPO services market.
