The total value of the market represents the demand for the service coming from a particular country.
- The French BPO services market recorded revenues of \$9.2 billion in 2023, representing a compound annual growth rate (CAGR) of 5.4% between 2018 and 2023.
- The vertical-specific BPO segment accounted for the market's largest proportion in 2023, with total revenues of \$2.7 billion, equivalent to 28.8% of the market's overall value.
- Companies in France are progressively outsourcing non-core tasks to BPO providers in order to decrease personnel expenses and improve operational efficiency.
