The services include the outsourcing of functions such as customer relationship management, finance & accounting, human resources, knowledge process outsourcing, procurement, and vertical-specific processes. The total value of the market represents the demand for the service coming from a particular country.
- The German BPO services market recorded revenues of \$11.1 billion in 2023, representing a compound annual growth rate (CAGR) of 5.5% between 2018 and 2023.
- The vertical-specific BPO segment accounted for the market's largest proportion in 2023, with total revenues of \$2.9 billion, equivalent to 26.5% of the market's overall value.
- Germany has a skilled labor shortage in many industries, particularly IT and digital services. This shortage is forcing businesses to outsource non-essential functions, allowing them to focus on key capabilities while using BPO services to handle regular work like data processing, customer support, and finance.
