- The Indian BPO services market recorded revenues of \$13.6 billion in 2023, representing a compound annual growth rate (CAGR) of 8.7% between 2018 and 2023.
- The vertical-specific BPO segment accounted for the market's largest proportion in 2023, with total revenues of \$3.5 billion, equivalent to 25.6% of the market's overall value.
- In 2023, India accounted for the largest share of 13.2% of the Asia-Pacific BPO services market.
