The services include the outsourcing of functions such as customer relationship management, finance & accounting, human resources, knowledge process outsourcing, procurement, and vertical-specific processes. The total value of the market represents the demand for the service coming from a particular country.
- The Japanese BPO services market recorded revenues of \$18.6 billion in 2023, representing a compound annual growth rate (CAGR) of 4.6% between 2018 and 2023.
- The vertical-specific BPO segment accounted for the market's largest proportion in 2023, with total revenues of \$7 billion, equivalent to 37.7% of the market's overall value.
- In 2023, Japan accounted for the largest share of 18.1% of the Asia-Pacific BPO services market.
