The services include the outsourcing of functions such as customer relationship management, finance & accounting, human resources, knowledge process outsourcing, procurement, and vertical-specific processes. The total value of the market represents the demand for the service coming from a particular country.
- The Scandinavian BPO services market recorded revenues of \$5.4 billion in 2023, representing a compound annual growth rate (CAGR) of 5.7% between 2018 and 2023.
- The vertical-specific BPO segment accounted for the market's largest proportion in 2023, with total revenues of \$1.3 billion, equivalent to 23.9% of the market's overall value.
- In 2023, Sweden accounted for the largest share of 37.5% of the Scandinavian BPO services market, followed by Norway at 23.5%, and Denmark at 21.1%.
