Summary

Global Aluminium industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2018-23, and forecast to 2028). Key Highlights

- The aluminium market includes primary aluminium (made from alumina) only. Secondary aluminium (made by the recycling of scrap aluminium) is excluded from our scope. Industry volume is defined as the quantity of primary aluminium produced at sites within each country or geographical region. Industry value is calculated as the production volume multiplied by the average manufacturer selling price, regardless of whether the production is sold to third parties or used in-house.
- The global aluminium industry recorded revenues of \$1,52,701.7 million in 2023, representing a compound annual growth rate (CAGR) of 3.7% between 2018 and 2023.
- Industry production volume increased with a CAGR of 1.8% between 2018 and 2023, to reach a total of 65,035.6 thousand tonnes in 2023.
- According to GlobalData, Asia-Pacific dominated the global aluminium industry in 2023, accounting for a share of 73.9%.
