- Market consumption volume increased with a CAGR of 1% between 2018 and 2023, to reach a total of 150.1 million units in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 3.2% for the five-year period 2023-28, which is expected to drive the market to a value of \$1,256.5 million by the end of 2028.
