- The Scandinavian Haircare market had total revenues of \$1,128.4 million in 2023, representing a compound annual growth rate (CAGR) of 1.9% between 2018 and 2023.
- Market consumption volumes declined with a negative CAGR of 0.5% between 2018 and 2023, to reach a total of 126.9 million units in 2023.
- The performance of the market is forecast to follow a similar pattern with an anticipated CAGR of 2% for the five-year period 2023-28, which is expected to drive the market to a value of \$1,248.6 million by the end of 2028.
