All currency conversions used in the creation of this report have been calculated using constant annual average 2023 exchange rates
- The Dutch Haircare market had total revenues of \$710.8 million in 2023, representing a compound annual growth rate (CAGR) of 0.8% between 2018 and 2023.
- Market consumption volumes declined with a negative CAGR of 0.2% between 2018 and 2023, to reach a total of 125.1 million units in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 1.5% for the five-year period 2023-28, which is expected to drive the market to a value of \$764.8 million by the end of 2028.
