- The Austrian hotels & motels industry recorded revenues of \$24.5 billion in 2023, representing a compound annual growth rate (CAGR) of 4.6% between 2018 and 2023.
- The number of establishments in the industry declined with a negative CAGR of 0.2% between 2018 and 2023, reaching a total of 11,895 in 2023.
- The growing travel and tourism expenditure is a key driver of revenue in the hotels & motels industry. According to the World Travel & Tourism Council (WTTC), the total travel and tourism spending in Austria reached \$27.2 billion in 2023, reflecting a 11.9% increase from 2022.
