- The growing travel and tourism expenditure is a key driver of revenue in the hotels & motels industry. According to the World Travel & Tourism Council (WTTC), the total travel and tourism spending in New Zealand reached \$10.1 billion in 2023, reflecting a 44.3% increase from 2022.
