- The number of establishments in the industry grew at a CAGR of 1.7% between 2018 and 2023, reaching a total of 1,122 in 2023.
- The growing travel and tourism expenditure is a key driver of revenue in the hotels & motels industry. According to the World Travel & Tourism Council (WTTC), the total travel and tourism spending by international visitors in Norway reached \$16.5 billion in 2023, reflecting a 0.3% increase from 2022.
